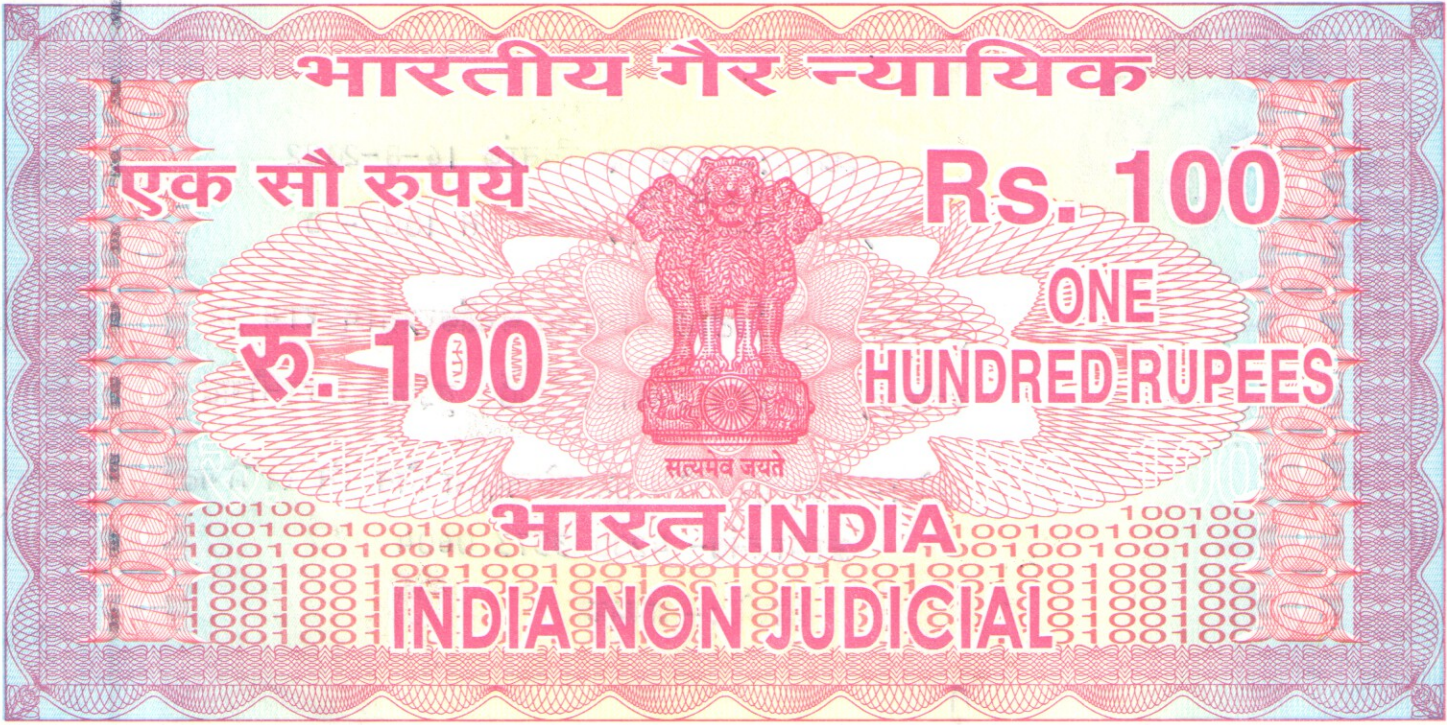




**Jaypee University of Engineering and Technology and the Jaiprakash Power Ventures Limited** shall be from now on collectively referred to as the "Parties" and individually as the "Party" for the sake of brevity where the context shall so require.

**WHEREAS**

- 1. Jaypee University of Engineering & Technology (JUET), Guna** has been established vide Government of Madhya Pradesh gazette extraordinary No.3 of 2010 dated 29th April 2010 as a first private university in the State of MP under the provisions of MP Niji Vishwavidyalaya Adhiniyam 2007. The UGC has notified the university under section 2(f) of the UGC Act, 1956 and accredited by NAAC with Grade "A" in the first cycle of Accreditation in 2016. It was established as a Jaypee Institute of Engineering and Technology, Guna, in 2003, based on the MoU signed between Jaiprakash Sewa Sansthan (a not-for-profit trust) and the Government of Madhya Pradesh.
- 2. Jaiprakash Power Ventures Limited (JPVL)**, an incorporated body corporate since 1994, engaged in the business of power generation, coal mine and cement grinding having its one Hydro Power Plant at Vishnuprayag, District Chamoli, Utrakhnad, two coal based thermal power plants at District Sagar (MP) and District Singrauli (MP), a Coal mine at Amelia (North) Coal Mines, District Singrauli (MP) and Cement Grinding Unit at District Singrauli (MP).

**3. Jaiprakash Sewa Sansthan (JSS)**, a not for profit trust, having its registered office at 63, Basant Lok, Vasant Vihar, New Delhi - 110057 and engaged in providing supports to various sections of society through several initiatives for over all socio economic development of community like education, skill development and employability, women empowerment, medical services, rural infrastructure development and ungraduation and animal husbandry and also acting as an implementation agency of JPVL for its CSR activities relating to promoting education, including special education and employment enhancing vocational skills especially among children, women, elderly, and the differently abled and livelihood enhancement projects, having its CSR registration NO. CSR00007458;

**4. JUET** is in need of affiliation / collaboration with industrial undertakings to provide "on site" practical training to its engineering students so as to enhance their skills and to expose them to actual industrial environment,

**NOW, through this Memorandum of Understanding, JUET and JPVL have agreed to work for joint collaboration on the broad areas which are mentioned below:**

**ARTICLE 1: Both parties agree to participate in following collaborative activities on basis of equality and reciprocity:**

1. To promote capacity building programmes launched by JUET/JPVL for better employability and entrepreneurship in the sink with nation building programmes.
2. To support the visit of students, internship and faculty members for the purpose of academics, research, training and publications, etc.
3. Extend cooperation for organizing workshop, seminars, conferences, training programmes jointly for the industry and academia, whenever and wherever feasible and preferential treatment to each other in levy of participation, facility use, hostel and guest house etc.
4. To develop and facilitate the setting up of Incubation/Innovation/product development centre in applied engineering.
5. Joint work on the development of Prototype and R&D..
6. The experts/faculty members of both parties may be included as resource persons for delivering lectures/talks on specialized topics.

#### **ARTICLE 2: Effective date and duration of MoU**

2. Duration of the MoU shall be for a period of 5 years from the effective date.
3. Either party can revoke this MoU by giving one month notice.

#### **ARTICLE 3: Financial Obligations**

There will be no financial obligation/binding on any of these two organisations.

#### **ARTICLE 4: Intellectual Property (IP) Rights:**

JUET and JPVL agree to respect each other's rights to intellectual property.

#### **ARTICLE 5: Confidentiality**




