MEMORANDUM OF UNDERSTANDING

AND

Kanpur Fertilizers & Chemicals Limited (hereafter referred to as "KFCL"), (CIN U24233UP2010PLC040828), a Public Company incorporated on 31st May, 2010, located at "CEE KAY ESTATE", Udyog Vihar, Panki Industrial Area, Kanpur-208022 (U.P.) India having its Registered Office at Sector-128, Noida-201304, Uttar Pradesh (India), being the SECOND PARTY

Jaypee University of Engineering and Technology and Kanpur Fertilizers & Chemicals Limited shall hereafter be collectively referred to as the "Parties" and individually as the "Party" for the sake of brevity where the context shall so require.

WHEREAS

Jaypee University of Engineering & Technology, Guna has been established vide Government of Madhya Pradesh (MP) Gazette Extraordinary No.3 of 2010 dated 29th April, 2010 as a first Private University in the State of MP under the provisions of MP Niji Vishwavidyalaya Adhiniyam, 2007. The University Grants Commission (UGC) has notified the University under Section 2(f) of the UGC Act, 1956 and accredited by National Assessment and Accreditation Council (NAAC) with Grade "A" in the first cycle of Accreditation in 2016. It was established as Jaypee Institute of Engineering and Technology, Guna, in 2003, based on the MoU signed between Jaiprakash Sewa Sansthan (a not-for-profit trust) and the Government of Madhya Pradesh.

WHEREAS

Kanpur Fertilizers & Chemicals Limited was incorporated on 31st May, 2010 and is operating a Fertilizer plant at Kanpur, Uttar Pradesh, famous for "CHAND CHHAP UREA".

It is part of Jaypee Group, which is engaged in Civil Engineering and Construction, Cement, Power, Real Estate, Expressways, Hospitality, Fertilizer, Health Care, Sports, Information Technology and Education (not-for-profit).

JUET, Guna and KFCL have agreed to collaborate on the broad areas which are mentioned below:

ARTICLE 1: JUET and KFCL agree to collaborate on following activities on the basis of equality and reciprocity

- To promote capacity building programmes launched by JUET/KFCL for better employability and entrepreneurship in synchronization with nation building programmes.
- 2. To sponsor students, interns and faculty members for promotion of academics, research, training and publications etc.
- 3. To co-operate and organize workshops, seminars, conferences, training programmes for the industry and academia, whenever and wherever feasible and afford preferences to each other in participation, facility use, hostel and guest house etc.
- 4. To develop and facilitate the setting up of Incubation/Innovation/product development centres in applied engineering.
- 5. To work jointly on the development of Prototype and R&D.
- 6. To develop/promote/encourage faculty members/senior officers of parties as resource members for delivering lectures/talks on specialized topics.
- 7. Other objects as may be necessary, from time to time and mutually agreed upon.

ARTICLE 2: Effective date and duration of MoU

- 1. This MoU shall be effective from the date of its execution by the parties.
- 2. Duration of the MoU shall be initially for a period of 5 years from the effective date.
- 3. Either party can revoke this MoU by giving one month notice to the other party.

ARTICLE 3: Financial Obligations

There will be no financial obligation/binding on any of the parties.

ARTICLE 4: Intellectual Property (IP) Rights:

JUET and KFCL agree to respect each other's rights to intellectual property.

ARTICLE 5: Confidentiality

If required, information may be disclosed or communicated to any third party with mutual consent.
